WSPA ASSOCIATES MEMBERSHIP ELIGIBILITY AND STRUCTURE

Eligibility

Individuals and corporations associated with and/or engaged in the oil and gas service industry are eligible to become members of the WSPA Associates, under the following stipulations:

1. Members should be willing to support the concept that an economically-viable, domestic oil and gas industry is a vital contributor to the economy of this region; and
2. Members should be willing to publicly participate as informed advocates in support of petroleum industry issues at the state, regional and local levels.

New Dues Structure

Dues are collected on an annual basis at the beginning of each year. All memberships expire on December 31st. The WSPA Associates membership fee is \$100, with an additional \$50.00 fee per chapter. Each company must designate the chapter(s) in which it wishes to participate, and must belong to at least one chapter. Multiple employees within a company are able to participate in the WSPA Associates activities.

All Associates Members are included in the WSPA Associates directory and identified on WSPA's web site at www.wspa.org. Members are entitled to participate in functions of any Associates Chapter. Each chapter will have programs focused on local issues and events.

Associates Members will be invited to periodic meetings to discuss issues of current interest, and will receive various WSPA publications.
